PARTICIPATION & TRANSPORTATION WAIVER:

I understand that participation in the Salem Recreation Pats Peak Ski Program involves transportation by bus and participation in recreational activities at Pats Peak, including skiing and/or snowboarding.

I understand that transportation and recreational activities involve inherent risks, including but not limited to falls, collisions, changes in weather and road conditions, equipment-related incidents, and other risks associated with travel and winter recreational activities.

I acknowledge that Salem Recreation, the Town of Salem, its employees, agents, volunteers, and representatives will take reasonable measures to provide a safe program environment. I agree that my child will follow the directions of Salem Recreation staff, bus drivers, Pats Peak personnel, and other authorized program personnel.

I understand that participation may be suspended or terminated if my child engages in unsafe, disruptive, or inappropriate behavior.

To the extent permitted by applicable law, I release and hold harmless the Town of Salem, Salem Recreation, and their employees, agents, volunteers, and representatives from claims arising from my child's participation in the program, except to the extent caused by negligence or other conduct for which liability cannot legally be waived.

I understand that this form does not replace any separate Pats Peak registration, rental, lesson, or liability forms that may be required.
